

TOWN OF ARMSTRONG CREEK
2023-2024 Snowplowing Contract

1. A contract with the town of Armstrong Creek must be signed by the owner or occupant, giving the town permission to enter upon his or her land and waiving redress for any damage caused.
2. All contracts must be signed, and all snowplowing fees paid before October 15th each year to save on collection costs. Residential rate is \$225; business rate is \$300; a \$40 charge for each application of salt/sand (billed monthly). Any late payments will result in an extra \$10 charge, *but no requests for plowing will be accepted after December 1st.*
3. Anyone desiring driveway plowed as a special one-time service must sign a contract **BEFORE** service is done. The charge for this service shall be \$50 per hour; with the time to start upon leaving the garage and to stop upon returning to same.
4. **If you are making a NEW snowplowing request, please wait until your driveway is approved BEFORE submitting your payment. Please submit the contract for approval before October 15th. CONTACT JAMES KOWALKOWSKI @ 715-889-3219 FOR EVALUATION AND APPROVAL.**
5. The owner/occupant is responsible for clearly marking with reflective markers any area that could cause problems for the plow (septic systems, drywells, steps, etc.).
6. The Town snowplow will not plow any driveway or plow around any buildings unless there is at least a five-foot clearance on all sides of the snowplow.
7. No driveways will be plowed unless there is a twelve-foot clearance from overhead obstructions such as trees, wires, etc.
8. The town reserves the right to refuse snowplowing on any driveway it deems in such condition as to render it unsuitable for its equipment. The town will not be liable for damage to driveways (gravel or blacktop), lawns, and yards.
9. State statutes require the town to plow town roads first; therefore, the plowing of driveways will be completed as time allows.
10. After road limits are in effect, the town will not plow any driveways unless a request is made to the road boss, town chair, or a town supervisor.
11. Generally, town plows will go out if there is a snowfall of approximately 3" or more; however, the decision to plow will be left up to the discretion of the Town Board.
