Note: Within Agriculturally Zoned areas, the maximum RV is one on a parcel of 2 ½ acres or parcels of 5 acres or greater two RVs may be sited. Residentially zoned property / lots are permitted to have one RV unit. Check your subdivision covenants for permitted uses.

See attached informational page regarding use of RV’s within Benona Township. RV permits are an annual permit expiring on December 31, 2026. The use of a RV within Benona Township is permitted from May 15<sup>th</sup> through September 15<sup>th</sup>, not to exceed thirty days continuous use in any one period.

**Seasonal Guest RV Temporary stay, on improved property. After sixteen (16) days, a permit is required with approval of a thirty (30) day time duration. Permit fee \$200.**

Please attach the following information:

1. Location of the parcel within Benona Township. **Show where the RV will be sited.** Agricultural setbacks are fifty (50) feet from any property line. In Residential, one RV per lot or parcel is permitted (Setbacks are: Front – 25 feet; Sides – 15 feet; Rear – 25 feet.) Check your local covenants for permitted use.
2. Health Department permit is required if septic tank is installed. Portable sewage tanks are allowed, but not recommended. Ground discharge is strictly forbidden. Sites may be inspected to conform with sanitary conditions. Fines for such violations will come from the Health Department and Benona Township.
