CHANGING OF THE SEASONS

BRUSH - Brush will continue to be picked up into the fall. Please make sure to pile brush parallel with the curb or street. Brush must be cut into lengths of no more than 10-12ft, stacked in piles up to 4 ft high and 4 ft deep. Please allow for space between each brush pile to keep them seperate.

LEAF PICKUP – Leaves will be vacuumed during leaf season. Please rake your leaves so they are in a row along the street (boulevard if you have one) but not in the street so they can easily be vacuumed. Please make sure there is no brush or garbage mixed with your leaves as this could potentially damage the machine.

Lawns should continue to be maintained at a height not to exceed six (6) inches. **Plantings** shall be maintained so as not to present hazards to adjoining properties or to persons or vehicles traveling on public ways. Dead or diseased plantings, trees, and limbs shall be removed.

UTILITY PAST DUE ACCOUNTS

If you have a past-due utility account, Wisconsin State Statute § 66.0809 requires municipalities to place delinquent water bills on the tax roll as a special charge against the property that was furnished with utility service.

The ability to collect for unpaid utility bills through the property tax roll generally has worked to keep the amount of municipal uncollectible debt to a minimum. This limits losses caused by unpaid utility bills and protects other utility customers from rate increases.

If you have a past-due utility account as of October 1, please make payment arrangements to pay the past-due balance in full by November 1st to avoid a 10% penalty, or by November 15th to avoid the past-due balance from being transferred to the tax roll. All past dues for Water, Sewer, Garbage & Recycling are included in your past-due utility account.

The utility does not have a lease agreement with a tenant, therefor, any past dues in tenant accounts follow the same process and will be placed on the property owners tax bill.

Notification Timeline

October 1st - Utility determines which accounts are in arrears as of this date.

October 15th - Utility sends written notice of any amounts in arrears as of October 1st to all property owners and tenants.

November 1st – Utility applies a 10% penalty. Addition of the penalty is not optional. November 16th – Utility transfers the unpaid arrears, plus the penalty, to the tax roll.
