BRUSH COLLECTION POLICY

This service is only available within the city limits of Clayton. Brush will be picked up every Friday and after severe storms. Adhere to the following required guidelines:

- The brush pile must be left within four (4) feet of the edge of the road. If near a sidewalk, please place the brush on the house side of the sidewalk.
- The brush pile cannot be placed under trees or overhead wires. This is dangerous to the equipment and operators. Brush piles must be kept away from mailboxes or other structures to avoid damage to the structure.
- The maximum diameter of limbs is no larger than six (6) inches. Anything thicker than six (6) inches will not be picked up. The brush pile cannot exceed 2.22 cubic yards, or approximately 20 standard wheelbarrow loads.
- Brush only. Do not include vines, root balls, building materials, trash, plastic, metal, wire, cardboard paper, or glass.
- No commercial debris. The City of Clayton will not pick up anything discarded by any commercial business.
- A waiver must be signed prior to brush collection for private road and property collections. All properties located within an HOA must have an HOA waiver with the HOA president signature during the current year. If we do not have one on file, it will be up to the homeowner to get this filled out.
- This service must be requested by Wednesday before collection day.
- Brush must be placed no sooner than the night before or no later than 7AM on collection day.
- The collection day could be subject to change due to the weather.
