**RESIDENTIAL PLUMBING PERMIT FEES** are based on the number of fixtures.

\$50.00 base fee plus \$10.00 for each fixture

Plus \$20.00 Administrative Fee

Plus \$1.00 State Surcharge

**COMMERCIAL PLUMBING PERMIT FEES** are based on valuation of the work being proposed. Valuation is defined as the sum of all materials, equipment and labor cost to complete the project. When materials, labor, or installation will be furnished by another party, the reasonable market value of those items must be included in the valuation. Valuation provided is subject to the review of the Planning Department.

<b>TOTAL VALUATION</b>	<b>Fee</b>
\$1 - \$1,300	\$50
\$1,301 - \$5,000	\$50 for the first \$1,300 plus \$3.02 for each additional \$100, or fraction thereof, up to and including \$1,300
\$5,001 - \$10,000	\$162 for the first \$5,000 plus \$2.70 for each additional \$100, or fraction thereof, up to and including \$5,000
\$10,001 - \$25,000	\$297 for the first \$10,000 plus \$2.35 for each additional \$100, or fraction thereof, up to and including \$25,000
\$25,001 - \$50,000	\$651 for the first \$25,000 plus \$2.14 for each additional \$100, or fraction thereof, up to and including \$50,000
\$50,001 and over	\$1,186 for the first \$50,000 plus \$1.80 for each additional \$100, or fraction thereof

**OTHER FEES**

- Plan Review Fee: For projects over \$30,000, 25% of the plumbing permit fee.
- Plus \$20.00 Administrative Fee
- State of Minnesota Surcharge: The fee, which is paid to the State and required by state statute is 0.0005 of the valuation of the permit with a minimum of \$1.00.
