INCIDENT	DATE	INCIDENT DETAILS:
DWI - Arrest-Formal Complaint	2025-12-15	Officer conducted a traffic stop for a stop sign violation. The 40-year Shorewood resident failed field sobriety tests and was arrested for 4th degree DWI. The driver tested a .13 ac. The driver was released pending Formal Complaint.

ACCIDENT	DATE	DETAILS
PI Accident - Driver Evaluation	2025-12-19	Officers were dispatched to an accident with injuries in the driveway of a residence on Minnetonka Blvd. Officers arrived and determined a single vehicle crashed into a tree while driving down the driveway. The driver of the vehicle complained of chest pain and was evaluated by Hennepin EMS. Kustom Karriers was dispatched at the drivers request to tow the vehicle, which was disabled. Due to the circumstances, a state crash report and driver evaluation form were both completed.
PD Accident - Citation	2025-12-27	Officer witnessed an accident at the intersection of State Highway 7 and Vine Hill Road. Officer gathered information, completed a crash exchange form and took photos of the accident. A citation was mailed to a driver for improper change of course. A state crash report was completed and attached.
