INCIDENT	DATE	INCIDENT DETAILS:
Juvenile Problem- Weapons/Assault	2025-10-02	Officers responded to a report of juveniles being shot with an airsoft gun. Several juveniles were located in the warming house restroom with an airsoft gun. Two individuals were identified as the ones who did the shooting. Both victims had no visible injuries, but reported being shot at twice and in the face. Charges are Pending.
Disorderly Conduct- Formal Complaint	2025-10-03	An officer was dispatched to the Deephaven Elementary School for a disturbance during morning drop-off. One individual was charged via Formal Complaint for Disorderly Conduct.
Fraud - Identity Theft	2025-10-03	A resident of Deephaven called to report fraud involving identity theft and an unauthorized withdrawal of money from her bank account.
Traffic Stop- DWI - Arrest	2025-10-16	Officer observed a vehicle speeding on Minnetonka Boulevard near the intersection of Northome Blvd. A traffic stop was conducted on the vehicle. While speaking with the driver, the Officer observed he had red watery eyes, slurred speech, and a moderate odor of a consumed alcoholic beverage coming from the vehicle. Officer performed Standardized Field Sobriety Tests on the driver. The Driver, a 31-year-old man from Deephaven, provided a PBT sample of .142 PBT and was placed under arrest for DWI. The vehicle was impounded. Officer also located illegal possession of marijuana in an improper container in the vehicle. The driver submitted to a breath test. The results yielded a final result of 0.12 BAC. Driver had a previous DWI conviction from August of 2025. The driver was transported and booked into the Hennepin County Jail.
Phone Call - Scam	2025-10-23	Officer took a phone call from a resident who was scammed out of money through a Facebook ad for an apartment rental in Boston. Officer gathered information from the reporting party who advised he had reported it to his bank and filed a consumer assistance report with the state.

	PD Accident - Hit Deer	2025-10-23	Officer responded to an accident for a vehicle that hit a deer on Minnetonka Blvd near Sibley Ave. The vehicle had minor damage and officer located the deer deceased in the woods near the accident site. Officer gathered information and provided the driver of the vehicle with a case number. Officer completed a state crash report, which is attached.
	PD Accident - Hit and Run	2025-10-23	Officer was dispatched to a hit and run accident involving a school bus and a parked trailer on Rutledge Road. Case still under investigation.
	PD Accident - Hit Deer	2025-10-23	Officer was dispatched to an accident for a vehicle that hit a deer on Minnetonka Blvd near Vine Hill Road. The vehicle had minor damage and officer located the deer in the woods near the accident site. Officer dispatched the deer. Officer gathered information and provided the driver of the vehicle with a case number. Officer completed a state crash report, which is attached.
