INCIDENT	DATE	INCIDENT DETAILS
Domestic Assault Arrest	2025-09-03	Officer was called for a domestic at the residence. The officer arrived and learned one of the parties had thrown a TV hitting the other party. The party that threw the TV was arrested for Domestic Assault and taken to the Hennepin County Jail. Charged with Disorderly Conduct and Domestic Assault.
Trespass- Flee on Foot- Underage Consumption	2025-09-13	Officer was called to a Burglary on Linwood Road. When the officer arrived on scene he learned that the home owners alarm had gone off notifying her that the deck door had been opened. The home owner said she yelled that she was calling the police. Several wet foot prints of bare feet were visible on the deck. While in the area checking along with two HCSO Water patrol units, three males were seen running from the area. All three males were detained and found to have been drinking under age. One of the males admitted that they had opened the door to the house before fleeing. Video was sent to the officer from a neighboring house of the three nude males running in the area. The case is under review by the City Attorney.
PD Accident - Hit and Run	2025-09-13	An officer was dispatched to property damage at 18409 Minnetonka Bl. A vehicle appeared to have run through a yard and hit a tree then return to the roadway. There was a piece of Mercedes Benz W205 left at the scene. No other information was available and there were no cameras in the area. No suspects at this time.
Theft	2025-09-17	Officer received a phone call in regards to a theft report. Officer spoke with the RP, who stated that she had a water pump stolen from her property. Unknown Suspect(s)
Domestic- Second Degree Assault- Arrest	2025-09-18	Officers responded to a domestic situation, where it was reported that two family members had been cut with a knife. The victims ran to the neighbor's home and were transported to HCMC in stable condition. The suspect ran from the home and returned to surrender. The suspect was arrested and transported to HCMC for care. When cleared from HCMC the suspect was transported to Hennepin Jail and charged with two counts of Second-Degree Assault.
HRO Violation	2025-09-20	An officer was notified of a possible Harassment Restraining Order violation. The case was sent to the City Attorney for review.

PD Accident	2025-09-11	A package delivery driver lost brakes near the intersection of Minnetonka Boulevard and Northome Boulevard while going westbound, they continued through the intersection onto Northome Boulevard and later purposely went off the road near Crest Avenue and struck a tree to stop the vehicle.
