The following statistics are Part 1 and Part 2 crimes reported for the month of June 2025:

INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Fraud Report	2025-06-02	A resident of Deephaven came into the police department lobby to report a fraudulent use of her bank debit card. An officer investigated the incident but was unable to identify a suspect.
Credit Card-Fraud	2025-06-04	Officer received a phone call in regards to a credit card theft. RP stated that she lost her credit card on May 24th, 2025. RP was unaware where or when on May 24th she lost the credit card at. RP stated that between May 24 to May 28th, she had fraudulent charges on her credit card. RP stated that she had a total loss of \$2,088.56. RP advised that the credit card company credited the money back to her, but requested that she report the incident to law enforcement.
Theft - Firearm	2025-06-05	A resident who has their house listed for sale called to report a firearm stolen from their home. The gun was entered as stolen. Many workers have been in and out of the home for months.
Curfew Violations-Fireworks-Citations	2025-06-08	Three juvenile males were setting off fireworks behind the Deephaven Elementary School. One male admitted to picking up the fireworks for the other two males. The male admitted to running off with the fireworks when I arrived on scene. The male showed me where he hid the fireworks and I seized them. The male was issued a citation for possession of illegal fireworks. Two others were cited for Curfew.
Underage Drinking-Curfew-Citations	2025-06-10	Officer was dispatched to the report of a loud party and juveniles running around on Northome Blvd. The officer arrived in the area and located several juveniles and found some of them had been drinking. Minor consumption and curfew citations were issued. The owner of the home where the reported juvenile party was being held at was contacted. The owner denied knowing about anyone drinking at his home.
Theft	2025-06-18	Officer received a phone call in regards to a theft report. RP stated that an elderly female has been taking plants out of a pot at the business. RP stated that she does not want the individual charged or trespassed, but wants Officers to speak with the individual.

Consumption Citation- Fake ID	2025-06-21	Male was found unresponsive on the ground while the officer was driving to a nearby call. The officer attempted to wake the male but he was slow to respond. The male eventually woke up and the officer smelled the odor of a consumed alcoholic beverage. The male stated he was over 21 years old and presented a DL from Illinois. The DL was found to be fake and the male eventually admitted to being under 21. The male was found to have a BAC of 0.184 and was issued a citation for minor consumption and possession of a fake ID. Sent to City Attorney for Formal Complaint.
Theft - Bikes	2025-06-23	An officer was dispatched to a bike theft report. Two bikes were taken from a front yard, estimated at \$100/each. The child's bike was described as a black trek bike with purple lettering. The adult bike was described as a green trek bike with a brown seat. There were no cameras and the RP just wanted officers aware if they see the bikes riding around.
Flee in Motor Vehicle	2025-06-28	Officer conducted a traffic stop on a vehicle that had gone around the road closed signs on Vine Hill Road. While the officer was speaking with the female he observed signs of impairment. While identifying the female and attempting to get her out of the vehicle a second driver almost struck the officer trying to pass through the narrow road. While the officer was attempting to speak with the first driver the female drove away fleeing the stop. The officer pursued and initially lost the suspect's vehicle, but found it crashed near the Carson Bay Boat launch and the entrance to Chimo West. Officers searched for the female with a drone and two K-9 teams. The female was identified by her passport and a SLMPD Officer who had stopped her a short while before. The vehicle was towed from the scene after the search was called off due to severe weather moving into the area.
