




INCREASE IN ASSESSED VALUE DROPS MILL RATE

The total assessed value of all properties in the City of Kewaunee increased by over \$98 million in 2025. As a result, there is a large drop in the City's net mill rate (tax rate). Although the mill rate dropped, there is still a potential for a property's tax bill to be higher than last year. Increases are dependent on how much the assessed value of that property increased from 2024 to 2025.

What Does Your Property Tax Payment Support?

- 36%** The **City** to provide basic services such as police, fire, plowing & repairing local roads, garbage pick-up and other items like running elections or doing building inspections.
- 37%** The **School District** to pay for building upkeep, utilities, salaries, furniture, technology and other supplies needed to run the schools.
- 24%** The **County** to pay for plowing & repairing County highways, Human Services, Sheriff's Department expenses, Veteran's Services, and much more.
- 3%** The **Technical College** to make it accessible to more students in our community.



GENERAL INFORMATION ABOUT YOUR PROPERTY TAX

When can I pay my taxes?

Tax bills are collected at City Hall (401 Fifth Street) during regular City Hall office hours:

Mon-Thurs 8:00 am-4:30 pm
Friday 8:00 am - 12:00 pm.

Payment can be made by cash, check, or money order. We do not accept credit/debit cards. Full or first installment payments are due on or before 1/31/2025.

There is a secure drop box in the front entrance of City Hall if you wish to drop your payment off after business hours.

Payments by mail must be made payable to **CITY OF KEWAUNEE** and mailed to:

If you are requesting a receipt, please enclose a self-addressed, stamped envelope.

City Hall will be closed December 24, December 25, December 31, and January 1.

How are my taxes calculated?

Your tax amount is derived by multiplying the value of your property as of January 1, 2025 and the mill rate for all taxing jurisdictions, then subtracting any applicable credits and adding any special assessments, special charges, or special taxes.

When am I eligible for a lottery credit?

If you owned your home on January 1, 2025 and it is your primary residence, you are eligible to receive the lottery credit. Please check your tax bill to verify you received this credit. If you do not see the credit on your bill, you can still apply for it at City Hall before 1/31/2026. If you own more than one home, you are only eligible for one lottery credit.

Why do I get the tax bill when my mortgage company pays my taxes?

Ultimately, it is your property and your responsibility to make sure your taxes are paid. Mortgage companies can make mistakes, so it is important for you to get your tax bill, and any other tax or assessment notices, so that you can check to make sure they are paying them and charging you the correct amount in your escrow account.

Who do I talk to about my property assessment?

2026 Dog Licenses

According to WI State Statutes and City of Kewaunee Municipal Code, all dogs must be licensed annually. Licenses are available at City Hall after December 10, 2025.



Fees:

Unaltered Dogs - \$10.00

Spayed Neutered - \$5.00

Late Fee (After March 31) - \$20.00 per dog

A current rabies certificate is required when applying for a license.

Per Local Ordinance, a fine may be imposed by the Police Department if any unlicensed animal is pickup up and held in our local pound.

Winter Parking Regulations

Kewaunee City Ordinance Sec. 78-92(d) states that no person shall park any vehicle for longer than 30 minutes between 1:00 a.m. and 6:00 a.m. from December 1 to April 1 on any city street.

In addition to this, per Kewaunee City Ordinance Sec. 94-343(11) (a) no vehicle shall be parked, stored, or otherwise kept upon any residential lot except:

1. In a garage, car port, or similar structure.
2. Upon an improved parking surface located in the front yard of a residence.
3. Upon an improved parking surface located in the side yard of any residence.

An improved parking surface is defined as an area used for the parking or storage of vehicles that is overlaid or otherwise improved with permeable or impermeable concrete, asphalt, paving stones, or other permanent durable material approved by the code administrator.

The Police Department will do their best to keep residents informed via the City of Kewaunee Police Department Facebook Page. If snow is in the forecast, assume the parking ban is in place.
