1. 1st Presentation, Ordinance No. 681 – An Ordinance amending Section 5.05(10) of the Municipal Code adding (D) regarding 15-minute parking commencing at 115' west of the centerline of Broadway Street and ending 315' west of the centerline of Broadway Street between the hours 7:00 AM and 7:00 PM except Sundays and Holidays.
