<b>Authority Conducting Elections</b>	<b>Local Non-County Political Subdivisions</b>  (County-ordered elections may not be held on this date. County Election Official may, but is not required to, contract to provide election services to political subdivisions holding elections on this date.)
<b><u>First Day to Apply for Ballot by Mail</u></b>	<b><u>Monday, January 1, 2024*</u></b>  *First day to file does not move because of New Year's Day holiday. An "Annual ABBM" or FPCA for a January or February 2024 election may be filed earlier, but not earlier than the 60th day before the date of the January or February election.
