NOTE 1 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Annual Expenditure Limitation Report (AELR) is presented as prescribed by the *Uniform Expenditure Reporting System* (UERS), as required by Arizona Revised Statutes §41-1279.07, and in accordance with the voter-approved alternative expenditure limitation adopted November 8, 2016, as authorized by the Arizona Constitution, Article IX, §20(9).

NOTE 3 – PENSION PLAN

The subtraction of \$38,106 for pension expense consists of the changes in the net pension liabilities, changes in deferred outflows related to pensions, and changes in deferred inflows related to pensions, recognized in the current year in the Enterprise Funds.

The addition of \$25,267 for pension contributions paid in the current year consists of the required pension contributions made to the Arizona State Retirement System from the Enterprise Funds.
