RESOLUTION TO CANVASS VOTE

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF TOMBSTONE, COCHISE COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 21, 2026.

WHEREAS, the City of Tombstone, Cochise County, Arizona did hold a **Primary Election** on the 21st day of July, 2026, for the election of Mayor and four (4) Council Members; and,

WHEREAS, the election returns have been presented to and canvassed by the Mayor and City Council pursuant to Arizona Revised Statutes §§ 16-642 and 16-646.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Tombstone, Cochise County, Arizona, as follows:

SECTION 1: The total number of ballots cast at said **Primary Election**, as shown by the poll lists, was 784.

SECTION 2: The number of ballots to be verified as Provisional Ballots were zero (0).

SECTION 3: The votes cast for the candidates for **Mayor** were as follows:

SECTION 4: Thhe votes cast for the candidates for **Council Member Ward I** were as follows:

SECTION 5: The votes cast for the candidates for **Council Member Ward II** were as follows:

Write-In: Unofficial	3

SECTION 6: The votes cast for the candidates for **Council Member Ward III** were as follows:

Write-In: Unofficial	1

SECTION 7: The votes cast for the candidates for **Council Member Ward IV** were as follows:

Newbauer, James "Lefty"	122
Burns, Jenn	95
Trujillo, Andrew	30
Write-In: Unofficial	3

SECTION 8: It is hereby found, determined and declared of record, that the following candidates did receive, in the **Primary Election**, more than one-half of the total number of valid votes cast and are hereby issued certificates of election and shall be declared to the office for which the person is a candidate, effective as of the date of the general election:

Ward III	Green, Jimmy	58

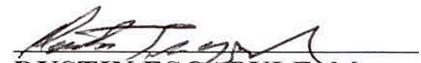
