

Live Today - Put It Away!
Voluntary Firearm Safekeeping Program Contract

This service is to provide safe-keeping of your firearm(s). You may also use this opportunity to dispose of unwanted ammunition. Ammunition turned in will not be stored and will be disposed of by the City of Wautoma Police Department per Department policy. Any surrendered firearm(s) shall be safely and securely stored at the City of Wautoma Police Department in a climate-controlled location within the department. All surrendered firearms shall be received unloaded and cased. The firearm owner shall retain ownership of all surrendered firearms. The City of Wautoma Police Department shall merely provide a safe location for them to be temporarily stored. The department does not assume any liability due to providing this service free of charge. This contract is between the firearm owner, named below, and the City of Wautoma Police Department:

You, as the owner, are voluntarily turning over firearms to the City of Wautoma Police Department for safe keeping. Your firearm(s) will be stored for up to one (1), two (2) or three (3) months at your discretion. Please specify the time period by checking and initialing the box for the amount of time the firearms are to be stored:

Three months

At the end of the aforementioned length of time, you may contact the department and make arrangements to receive the firearm(s) being surrendered. If you wish the department to continue to hold your firearm(s), you need to notify the department of your decision and sign a new agreement at that time. You may opt to receive your firearm(s) at any time prior to the time set forth in the agreement by contacting the department to make those arrangements. The owner will need to pick up the firearms and sign a property release form stating that the firearm(s) have been taken back into the owner's possession. The owner agrees that the City of Wautoma and/or the City of Wautoma Police Department, their employees and/or agents are not liable for any and all damage to the firearm(s) while the firearm(s) are in the custody of the City of Wautoma Police Department.

If the owner chooses to permanently surrender any firearm(s) they shall notify the department in writing. Abandoned / permanently surrendered firearms shall be destroyed per department policy. If the department does not have contact with the owner, and after reasonable attempts to contact the owner, the firearm(s) shall be considered abandoned after 12 months from the pick-up date on this agreement. By signing this contract, the firearm owner agrees that this contract and the actions taken by the City of Wautoma and/or the City of Wautoma Police Department, their employees and/or agents, as authorized by this contract shall not be deemed or construed as a violation of firearm owner's Constitutional rights, and firearm(s) owner waives their right to make such a claim against the City of Wautoma, the City of Wautoma Police Department, and/or their employees and/or agents.

Your name, weapon, or the fact it is being serviced here is confidential and private, except as necessary for federal licensing requirements or based on Federal Freedom of Information Act request(s).
