INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Alarm - Residential - Cancelled	2022-08-02	An officer was dispatched to a residential alarm in Woodland, while in route to the home the officer was cancelled with proper code.
Alarm - Residential	2022-08-03	Officers responded to a residential burglary alarm covering inside motion. Cleaners were just arriving and had not entered house yet. Officers checked house and found all ok.
Wire Down	2022-08-03	Officer was dispatched to the listed residence for a wire down. RP stated that he contacted Xcel Energy earlier in the day, but they had still not come out. Dispatch confirmed with Xcel Energy that they had gotten the maintenance request, and would be there eventually to fix the wire.
Road Debris - Tree Branch	2022-08-06	An officer removed a tree branch from the roadway.
Alarm - Residential	2022-08-07	An officer was dispatched to a residential alarm in Woodland, while in route the officer was canceled with proper code.
Traffic Stop - Verbal Warning	2022-08-08	An officer stopped a juvenile on a golf cart in Woodland for operating on the roadway, the juvenile was followed home and the officer spoke with the father and issued a verbal warning.

Directed Patrol	2022-08-08	An officer conducted directed patrol of Breezy Point Road for speed, one vehicle was stopped and cited for speed.
Traffic Stop - Citation	2022-08-08	Traffic Stop - Citation for speed, 44 mph in a 25-mph zone. Driver going to Apple Store Appointment at 1115 hours.
Alarm - Residential	2022-08-08	Officer was dispatched to a residential panic/hold up alarm. Officer and Minnetonka Police Officer responded to the location and made contact with the homeowner who stated her granddaughter was attempting to set the alarm and must've activated the panic alarm. Officer verified everyone in the home was safe and did not need police assistance. Alarm report was completed.
Directed Patrol	2022-08-09	An officer conducted directed patrol of Breezy Point Road for speed, no violations observed.
House Check - Information	2022-08-09	A resident called to request house checks.
Fire Alarm - Residential	2022-08-10	Officer dispatched to a residential fire alarm. Officer arrived and found the fire department speaking with contractors that set off alarm, false trip.
Directed Patrol	2022-08-14	An officer conducted directed patrol of Breezy Point Road for speed, no violations observed.

Directed Patrol	2022-08-16	An officer conducted directed patrol of the intersection of Maplewood Road and Breezy Point Road after a resident of Woodland reported a dump truck traveled through the area at a high rate of speed, two vehicles were stopped for traffic violations and verbally warned.

Dog at Large - GOA	2022-08-20	An officer was dispatched to a dog at large at a residence in Woodland, the officer arrived on scene and the homeowner advised the dog left the area.
Noise Complaint	2022-08-23	Officer was dispatched a noise complaint due to construction continuing past 6 PM. RP requested Officers to advise the construction workers of the Woodland ordinance. Officer visited the construction site and the workers were GOA.
Fire Alarm - Residential - Cancelled	2022-08-24	Officers were dispatched to a residential fire alarm at list address. As officers were in in route, dispatch gave proper code to cancel.

Alarm - Residential	2022-08-25	Officer responded to a burglary alarm covering a detached garage. Officer found the garage all secure. Alarm report left at main house.
Alarm - Residential	2022-08-27	An officer was dispatched to a residential alarm at a home in Woodland, officer made contact with the homeowner who was out of town and advised their kids and mother in law set the alarm off. The homeowner gave proper code to the alarm company but the alarm company wasn't able to get a hold of Hennepin County Dispatch, officer left an alarm report on site with the mother in law and marked it as no charge.
