The proposed ordinance revision is as follows:

AN ORDINANCE TO CREATE SECTION II(25) OF THE ORDINANCES OF THE CONSOLIDATED KOSHKONONG SANITARY DISTRICT ADOPTING WISCONSIN STATUTES, SECTION 106.50, AS AMENDED, RELATING TO THE EQUAL RIGHTS OF ALL PERSONS TO FAIR HOUSING, AND PROVIDING MEANS FOR THE IMPLEMENTATION AND ENFORCEMENT THEREOF.

THE COMMISSIONERS OF THE CONSOLIDATED KOSHKONONG SANITARY DISTRICT DO ORDAIN AS FOLLOWS:

Section II(25) of the Administrative Ordinances is created to read as follows:

## FAIR AND OPEN HOUSING

WHEREAS, the Board for the Consolidated Koshkonong Sanitary District, Rock County, Wisconsin, recognizes its responsibilities under Section 106.50, Wisconsin Statues, as amended, and endorses the concepts of fair and open housing for all persons and prohibition of discrimination therein:

## THEREFORE, BE IT ORDAINED THAT:

- 1. The Board for the Consolidated Koshkonong Sanitary District, Rock County, Wisconsin, hereby adopts Section 106.50, Wisconsin Statutes, as amended, and all subsequent amendments thereto.
- 2. The officials and employees of the Consolidated Koshkonong Sanitary District shall assist in the orderly prevention and removal of all discrimination in housing within the Consolidated Koshkonong Sanitary District implementing the authority and enforcement procedures set forth in Section 106.50, Wisconsin Statutes, as amended.
- 3. The Clerk shall maintain forms for complaints to be filed under Section 106.50, Wisconsin Statutes, as amended, and shall assist any person alleging a violation thereof in the Consolidated Koshkonong Sanitary District to file a complaint thereunder with the Wisconsin Department of Work Force Development, Equal Rights Division, for enforcement of Section 106.50, Wisconsin Statutes, as amended.
