**RESOLUTION AUTHORIZING THE ACCEPTANCE OF THE STATE OF NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY, OFFICE OF THE ATTORNEY GENERAL SFY21 BODY-WORN CAMERA GRANT PROGRAM STATE FISCAL YEAR 2021**

**WHEREAS**, Colts Neck Township desires to accept funding in the amount of \$61,140.00 with no match under the SFY21 Body-Worn Camera Grant Program, Award# 21-BWC-108, Subaward Period: January 1, 2021 - December 31, 2025; and

**WHEREAS**, Colts Neck Township has submitted an application for the Grant Award that has been required by the State of New Jersey Department of Law and Public Safety, Office of the Attorney General for the award period of January 1, 2021 – December 31, 2025; and
