## **ORDINANCE 2021-16**

## AN ORDINANCE OF COLTS NECK TOWNSHIP IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY, AMENDING ORDINANCE 2021-4 AN ORDINANCE SETTING THE SALARY AND WAGE RANGES FOR TOWNSHIP EMPLOYEES

**BE IT ORDAINED** by the Township Committee of Colts Neck Township, in the County of Monmouth, State of New Jersey that the purpose of this Ordinance is to set the salary and wage ranges paid within the Township as follows:

SECTION ONE: The minimum and maximum salary range for employees employed on an annual salary basis in the following positions within Colts Neck Township, in the County of Monmouth, are hereby fixed as follows:

Title	Department	Minimum	Maximum
Court Administrator	Municipal Court	\$45,000	\$80,000
Deputy Court Administrator	Municipal Court	\$40,000	\$75,000
Violations Clerk	Municipal Court	\$35,000	\$55,000
Assistant Violations Clerk	Municipal Court	\$30,000	\$50,000
Assistant Violations Clerk - Seasonal	Municipal Court	\$12/hour	\$15/hour

**SECTION TWO:** The Township reserves the right to pay a salary to any new employee at any figure between the minimum and maximum salary provided for such position and not necessarily the minimum salary.

**SECTION THREE:** The adoption of this Ordinance shall not operate to either increase or decrease the present pay of any employee of Colts Neck Township, and the salaries and compensations provided by existing ordinances shall remain in full force and effect until such time as the Township Committee may grant and approve such additional increments of salary as may be deemed advisable pursuant to the terms of this Ordinance.

SECTION FOUR: A resolution of the Township Committee establishing specific salaries or wages may be made retroactive to January 1<sup>st</sup> of the year in which the resolution is adopted or may establish a date on which the salary shall take effect.

**SECTION FIVE:** All ordinances or parts of ordinances, which may be inconsistent with the terms of this ordinance, are to the extent of such inconsistency hereby repealed.

**BE IT FURTHER ORDAINED,** this Ordinance shall take effect immediately upon passage, publication and filing according to law.
