**RESOLUTION OF SUPPORT TO THE NEW JERSEY DEPARTMENT OF
TRANSPORTATION (NJDOT) FOR VARIOUS TRAFFIC REGULATION
REVISIONS AND ROADWAY IMPROVEMENTS ALONG ROUTE 34 IN
COLTS NECK TOWNSHIP**

WHEREAS, as per N.J.S.A. 39:4-8.3 and 39:4-197(1)h, the regulations of entrance/exits to and from state highways, from parking yards and parking places to which the public is invited, are established by a Traffic Regulation Order (TRO); and

WHEREAS, an initial step in the TRO process is to receive a Resolution of Support from the municipal governing body pursuant to N.J.S.A. 39:4-8.4(c).

NOW THEREFORE BE IT RESOLVED, that the Township Committee of Colts Neck Township supports the following:

**Route NJ 34
In the Township of Colts Neck
County of Monmouth**

1. Center Lane for Left Turns Only:

Beginning at a point 1,400 feet north of the northerly curb line of Trump National Boulevard, extending to a point 600 feet northerly therefrom (approximate mile posts 12.97 to 13.08).

2. Left Lane for Left Turn Only:

From northbound on Route NJ 34 to westbound into the “Orchards at Colts Neck” driveway, also known as Block 46, Lot 13 of the official tax map of the Township of Colts Neck, between the centerline of the driveway to “Orchards at Colts Neck” and a point 100 feet southerly therefrom.

3. Turn Prohibitions:

No person shall make a turn at any location and in the manner described herein:

Route NJ 34 and the driveway of Investors Bank, located at 360 Route 34 (Block 31.1, Lot 9) 690 feet south of the southerly curb Line of Merchants Way (Approximate mile post 13.33)	Left Turns	Eastbound from the Investors Bank driveway to Route NJ 34 northbound.
Route NJ 34 and the driveway of Orchards at Colts Neck, located at 340 Route 34 (Block 46, Lot 13) 525 feet south of the southerly curb Line of County Route 537 (Approximate mile post 13.10)	Left Turns	Eastbound from the Orchards at Colts Neck driveway to Route NJ 34 northbound.
Route NJ 34 and the driveway of the Martin Property, located at 341 Route 34 (Block 48, Lot 1) 2,100 feet north of the northerly curb Line of Trump National Boulevard (Approximate mile post 13.10)	Left Turns	Westbound from the Martin property driveway to Route NJ 34 southbound.
Route NJ 34 and the driveway of the Martin Property, located at 341 Route 34 (Block 48, Lot 1) 2,100 feet north of the northerly curb Line of Trump National Boulevard	Left Turns	Southbound from Route NJ 34 to the Martin Property driveway eastbound.


4. “One Way” Entrance/Exits

The driveways described are designated as “One-Way” Entrance/Exit and traffic shall move as indicated:

<u>Intersection/Location</u>	<u>Designation</u>	<u>Direction</u>
At the southerly most driveway of the south parking area of “Brock Farms”, located at 341 Route 32 (Block 48 Lot 11), 660 Feet north of the northerly curb Line of County Route 537 (approximate mile post 13.35).	Entrance Only	Eastbound
At the northerly most driveway of the south parking area of “Brock Farms”, located at 341 Route 32 (Block 48 Lot 11), 840 Feet north of the northerly curb Line of County Route 537 (approximate mile post 13.35).	Exit Only	Westbound
At the southerly most driveway of the north parking area of “Brock Farms”, located at 341 Route 32 (Block 48 Lot 11), 1,025 Feet north of the northerly curb Line of County Route 537 (approximate mile post 13.42).	Entrance Only	Eastbound
At the southerly most driveway of the north parking area of “Brock Farms”, located at 341 Route 32 (Block 48 Lot 11), 1,090 Feet north of the northerly curb Line of County Route 537 (approximate mile post 13.42).	Exit Only	Westbound
At the southerly most driveway of the “Siam Thai Restaurant”, Located at 323 Route 34 (Block 48, Lot 3), 1,730 feet north of the Northerly curb line of Trump National Boulevard (approximate mile post 13.05).	Entrance Only	Eastbound
At the northerly most driveway of the “Siam Thai Restaurant”, Located at 323 Route 34 (Block 48, Lot 3), 1,840 feet north of the Northerly curb line of Trump National Boulevard (approximate mile post 13.05).	Exit Only	Westbound

BE IT FURTHER RESOLVED, the Township Committee of Colts Neck Township concurs that any approved traffic regulations in conflict with or inconsistent with the provisions of this Resolution be rescinded upon approval of the Traffic Regulation Order.
