

RESOLUTION 2021-76

**APPROVING AND AUTHORIZING THE EXECUTION
OF A SHARED SERVICE AGREEMENT
BETWEEN COLTS NECK TOWNSHIP AND THE
COLTS NECK TOWNSHIP SCHOOLS BOARD OF EDUCATION
(SPECIAL LAW ENFORCEMENT OFFICERS III, SLEO III)**

WHEREAS, pursuant to N.J.S.A 40A:65-1 et seq., municipalities and local boards of education may enter into agreements for shared services to provide or receive any service that the local unit participating agreement is empowered to provide or receive within its own jurisdiction; and

WHEREAS, the agreement must comply with the requirements of N.J.S.A. 40A:65-7 and specify the services to be performed under the agreement, procedures for payment, and assignment and allocation of responsibility for meeting standards between and among the parties; and

WHEREAS, Colts Neck Township and the Colts Neck Township Schools Board of Education desire to join together to provide a Class III Special Law Enforcement Officer (SLEO III) position for the time specified as April 14, 2021 – June 30, 2022 pursuant to the attached Shared Service Agreement; and

WHEREAS, Colts Neck Township desires to enter into an agreement with the Colts Neck Township Schools Board of Education for the purpose of setting forth the terms and conditions regarding the assignment of the Class III Special Law Enforcement Officer (SLEO III) position.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that it hereby approves and authorizes the Mayor, Administrator, and Clerk to execute a shared service agreement between Colts Neck Township and the Colts Neck Township Schools Board of Education for the period commencing April 14, 2021 and ending June 30, 2022.
