RESOLUTION AUTHORIZING THE ASSIGNMENT OF THE COLTS NECK RECYCLING SERVICES COLLECTION CONTRACT BETWEEN COLTS NECK TOWNSHIP AND SAKOUTIS BROTHERS DISPOSAL INC. DATED NOVEMBER 14, 2019

WHEREAS, bids for recycling services were duly advertised and publicly read on August 8, 2019 pursuant to law; and

WHEREAS, Colts Neck Township ("Township") adopted Resolution 2019-179 awarding said contract to Sakoutis Brothers Disposal, Inc., 113 Route 34, Farmingdale, New Jersey 07727, for a two year period with an optional twelve-month extension; and

WHEREAS, Colts Neck Township and Sakoutis Brothers Disposal, Inc. mutually agreed to exercise the twelve-month extension from January 1, 2022 through December 31, 2022; and

WHEREAS, Colts Neck Township adopted Resolution 2022-32 authorizing the twelvemonth contract extension for recycling services.

WHEREAS, Sakoutis Brothers Disposal, Inc. has recently entered into an agreement to consolidate its hauling business with Republic Service of New Jersey, LLC, which is part of a national provider of hauling services; and

WHEREAS, Sakoutis Brothers Disposal, Inc.'s consolidation with Republic Service of New Jersey, LLC, would purportedly result in less truck traffic in Colts Neck without changing the services, prices, terms, or conditions provided by Sakoutis Brothers Disposal, Inc. to the Township; and

WHEREAS, in order for Sakoutis Brothers Disposal, Inc. to consolidate with Republic Service of New Jersey, LLC, Sakoutis Brothers Disposal, Inc. must obtain the consent of the Township to the assignment of the recycling services contract be; and

WHEREAS, Sakoutis Brothers Disposal, Inc. has requested that the Township assign the recycling services contract to Republic Service of New Jersey, LLC; and

WHEREAS, the Township Committee finds that assigning the recycling services contract to the Republic Service of New Jersey, LLC, is in the best interests of the Township;

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that the Governing Body does hereby approve the request of Sakoutis Brothers Disposal, Inc. to assign the recycling services contract for the remainder of the term to Republic Service of New Jersey, LLC; and

BE IT FURTHER RESOLVED, that the Mayor and Clerk are hereby authorized to execute all documents in this regard; and
