COLTS NECK TOWNSHIP ORDINANCE NUMBER 2022-6

CAPITAL ORDINANCE PROVIDING FOR VARIOUS GENERAL CAPITAL IMPROVEMENTS AND ACQUISITION AND INSTALLATION OF VARIOUS EQUIPMENT, BY AND IN COLTS NECK TOWNSHIP, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$165,701 THEREFOR FROM THE CAPITAL ACCOUNT TO PAY FOR THE COST THEREOF

WHEREAS, Colts Neck Township, in the County of Monmouth, State of New Jersey (the "Township"), wishes to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software and printer improvements for the Finance Department (\$13,000); turnout gear, radio equipment and vehicle charging bases for the Fire Department (\$63,701); and Township signage, a grapple bucket and bleacher pads for Five Points Recreation Park for the Public Works Department (\$89,000); and

WHEREAS, the cost of said improvements or purposes is estimated to be \$165,701; and

WHEREAS, the Township desires to authorize the appropriation and expenditure of \$165,701 from the Capital Account to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software and printer improvements for the Finance Department (\$13,000); turnout gear, radio equipment and vehicle charging bases for the Fire Department (\$63,701); and Township signage, a grapple bucket and bleacher pads for Five Points Recreation Park for the Public Works Department (\$89,000).

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF COLTS NECK TOWNSHIP, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The capital improvements or purposes described below are hereby authorized as general capital improvements to be undertaken by the Township. For said improvements or purposes, there is hereby appropriated the amount of \$165,701 from the Capital Account to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software and printer improvements for the Finance Department (\$13,000); turnout gear, radio equipment and vehicle charging bases for the Fire Department (\$63,701); and Township signage, a grapple bucket and bleacher pads for Five Points Recreation Park for the Public Works Department (\$89,000).

SECTION 2. The expenditure of the \$165,701 consisting of an appropriation of \$165,701 from the Capital Account for the improvements or purposes set forth in Section 1 hereof is hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer and any other official/officer of the Township are each hereby authorized and directed to execute, deliver and perform any agreement to undertake the improvement or purpose set forth herein and to effectuate the transaction contemplated hereby.

SECTION 3. The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency

herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the Office of the Clerk and is available for public inspection.

SECTION 4. This ordinance shall take effect immediately after final adoption as described in N.J.S.A. 40:49-2.
