

**RESOLUTION 2022-93**

**RESOLUTION RENAMING THE DRIVEWAY PREVIOUSLY KNOWN AS  
WINTHROP DRIVE TO VETERANS WAY**

**WHEREAS**, a private driveway known as Winthrop Drive is located in Colts Neck Township (the "Township"). Winthrop Drive services the Township's current Town Hall, the Township's branch of the Monmouth County Library System, and the Township's new planned municipal building; and

**WHEREAS**, Winthrop Drive is a driveway owned by the Township, located directly behind the Township's current Town Hall, and is designated on the Township's Official Tax Map as Block 16, Lot 11, commonly known as 124-126 Cedar Drive; and

**WHEREAS**, it is the Township Committee's desire to honor Colts Neck Township veterans, particularly those who gave the ultimate sacrifice, this Memorial Day by permanently renaming the driveway servicing the Township's main municipal buildings as Veterans Way; and

**WHEREAS**, the Township will notify all interested parties of the change, including but not limited to the United States Post Office, the Monmouth County Library System, and the Township Tax Assessor.

**NOW THEREFORE BE IT RESOLVED**, by the Township Committee of Colts Neck Township that it hereby authorizes the change of the driveway name from Winthrop Drive to Veterans Way, effective Memorial Day 2022, Monday, May 30, 2022; and

**BE IT FURTHER RESOLVED**, that the Township buildings located on Veterans Way shall have the following addresses:

1. New Township Municipal Building – 1 Veterans Way
2. Monmouth County Library, Colts Neck Branch – 2 Veterans Way
3. Town Hall – 3 Veterans Way

**BE IT FURTHER RESOLVED**, and that the Township Administrator, Township Planner/Zoning Officer, and the Township Tax Assessor may take whatever actions necessary to amend the official map of the Township to reflect this name change; and

**BE IT FURTHER RESOLVED**, that a copy of this resolution be forwarded to the following:

1. Kathleen Capristo, Township Administrator; and
2. Bill Laird, Township Tax Assessor; and
3. Jan F. Tumiwa, Colts Neck Township Postmaster; and
4. Judith Tolchin, Monmouth County Library System Director.
