APPROVING AND AUTHORIZING THE EXECUTION OF AN ADDENDUM TO THE SHARED SERVICES AGREEMENT BETWEEN COLTS NECK TOWNSHIP AND THE COLTS NECK TOWNSHIP SCHOOLS BOARD OF EDUCATION (SPECIAL LAW ENFORCEMENT OFFICERS III, SLEO III)

WHEREAS, pursuant to N.J.S.A 40A:65-1 et seq., municipalities and local boards of education may enter into agreements for shared services to provide or receive any service that the local unit participating agreement is empowered to provide or receive within its own jurisdiction; and

WHEREAS, the agreement must comply with the requirements of N.J.S.A. 40A:65-7 and specify the services to be performed under the agreement, procedures for payment, and assignment and allocation of responsibility for meeting standards between and among the parties; and

WHEREAS, Colts Neck Township and the Colts Neck Township Schools Board of Education have modified the original agreement resulting in an addendum; and

WHEREAS, the following is noted in the addendum:

1. Effective July 1, 2022, it is hereby understood and agreed by the parties that for the 2022/23 school year, the phrase, "regular hour of operation", as expressed in section II. C., shall include Board of Education student summer program(s) operating hours, unless otherwise mutually agreed upon in writing by both parties.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that it hereby approves and authorizes the Mayor, Administrator, and Clerk to execute an addendum to the shared service agreement between Colts Neck Township and the Colts Neck Township Schools Board of Education for the period commencing July 1, 2022 and ending June 30, 2023.
