

**RESOLUTION 2022-185**

**AUTHORIZING THE MAYOR AND MUNICIPAL CLERK TO EXECUTE  
SHARED SERVICE AGREEMENTS BETWEEN COLTS NECK TOWNSHIP  
AND THE TOWNSHIP OF MARLBORO FOR THE USE OF COLTS NECK  
TOWNSHIP'S FIRING RANGE BY THE TOWNSHIP OF MARLBORO'S  
POLICE DEPARTMENT AND FOR DECONTAMINATION SERVICES  
PROVIDED BY THE TOWNSHIP OF MARLBORO TO THE COLTS NECK  
TOWNSHIP POLICE, FIRE DEPARTMENT AND FIRST AID SQUAD**

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et. Seq. permits municipalities and other local units to enter into Shared Services Agreements with other governmental units by adoption of a Resolution authorizing such shared services; and

WHEREAS, Colts Neck Township and the Township of Marlboro are local units defined by N.J.S.A. 40A:65-3; and

WHEREAS, Colts Neck Township and the Township of Marlboro are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Service Agreement pursuant to the Act; and

WHEREAS, Colts Neck Township operates and maintains a Police Firearms Training Facility located at 231-A Route 34, Colts Neck, NJ 07722; and

WHEREAS, the Township of Marlboro Office of Emergency Management (OEM) operates and maintains a Decontamination Facility located at 1979 Township Drive, Marlboro, NJ 07746; and

WHEREAS, the Township of Marlboro has requested to utilize the Firearms Training Facility operated and maintained by Colts Neck Township; and

WHEREAS, Colts Neck Township and the Township of Marlboro have found it beneficial to enter into Shared Service Agreements for the above-mentioned uses; and

WHEREAS, the Chief of Police of Colts Neck Township has recommended that the Shared Service Agreements with the Township of Marlboro be extended through December 31, 2023.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that it hereby approves and authorizes the Mayor and Clerk to execute Shared Service Agreements between Colts Neck Township and the Township of Marlboro for the use of Colts Neck Township's firing range by the Township of Marlboro's Police Department and for decontamination services provided by the Township of Marlboro to the Colts Neck Township Police, Fire Department and First Aid Squad.
