

**RESOLUTION 2023-80**

**AUTHORIZING SALE OF MUNICIPAL PERSONAL PROPERTY  
THROUGH ON-LINE AUCTION**

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of Colts Neck Township as follows:

1. That the surplus personal property listed in “Schedule A” attached hereto is declared surplus and no longer needed for public purposes.
2. That the Township Administrator is hereby authorized to execute a contract with GovDeals, 100 Capital Commerce Boulevard, Suite 110, Montgomery, Alabama 36117 to conduct an on-line auction of said surplus property.
3. That said on-line auction will commence on May 23, 2023 and close on May 30, 2023 at website <https://www.govdeals.com>.
4. That the Municipal Clerk is authorized to advertise said sale of surplus property pursuant to law.
