

**ORDINANCE 2023-9**

**CAPITAL ORDINANCE PROVIDING FOR VARIOUS  
GENERAL CAPITAL IMPROVEMENTS AND ACQUISITION  
AND INSTALLATION OF VARIOUS EQUIPMENT, BY AND  
IN COLTS NECK TOWNSHIP, IN THE COUNTY OF  
MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING  
\$371,000 THEREFOR FROM THE CAPITAL ACCOUNT TO  
PAY FOR THE COST THEREOF**

**WHEREAS**, COLTS NECK TOWNSHIP, in the County of Monmouth, State of New Jersey (the "Township"), wishes to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software, printer and copier improvements for the Finance Department (\$30,000); turnout gear, radio equipment and SCBA packs for the Fire Department (\$89,500); building improvements including, but not limited to, replacement of boiler, cupola, sprinklers and HVAC at Town Hall, and acquisition of equipment for the Public Works Department (\$190,000); and computer hardware, software, printers, radar units and mobile radios for the Police Department (\$61,500); and

**WHEREAS**, the cost of said improvements or purposes is estimated to be \$371,000; and

**WHEREAS**, the Township desires to authorize the appropriation and expenditure of \$371,000 from the Capital Account to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software, printer and copier improvements for the Finance Department (\$30,000); turnout gear, radio equipment and SCBA packs for the Fire Department (\$89,500); building improvements

including, but not limited to, replacement of boiler, cupola, sprinklers and HVAC at Town Hall, and acquisition of equipment for the Public Works Department (\$190,000); and computer hardware, software, printers, radar units and mobile radios for the Police Department (\$61,500).

**BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COMMITTEE OF COLTS NECK TOWNSHIP, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY** (a majority of the full membership thereof affirmatively concurring), **AS FOLLOWS:**

**SECTION 1.** The capital improvements or purposes described below are hereby authorized as general capital improvements to be undertaken by the Township. For said improvements or purposes, there is hereby appropriated the amount of \$371,000 from the Capital Account to undertake various general capital improvements and the acquisition and installation, as applicable, of various equipment in and throughout the Township including, but not limited to, computer hardware, software, printer and copier improvements for the Finance Department (\$30,000); turnout gear, radio equipment and SCBA packs for the Fire Department (\$89,500); building improvements including, but not limited to, replacement of boiler, cupola, sprinklers and HVAC at Town Hall, and acquisition of equipment for the Public Works Department (\$190,000); and computer hardware, software, printers, radar units and mobile radios for the Police Department (\$61,500).

**SECTION 2.** The expenditure of the \$371,000 consisting of an appropriation of \$371,000 from the Capital Account for the improvements or purposes set forth in Section 1 hereof is hereby authorized and approved. The Mayor, the Clerk, the

Chief Financial Officer and any other official/officer of the Township are each hereby authorized and directed to execute, deliver and perform any agreement to undertake the improvement or purpose set forth herein and to effectuate the transaction contemplated hereby.

**SECTION 3.** The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the Office of the Clerk and is available for public inspection.

**SECTION 4.** This ordinance shall take effect immediately after final adoption as described in N.J.S.A. 40:49-2.


