ORDINANCE NO. 2023-15

ORDINANCE AMENDING SECTION 24, "SCHEDULE II: NO PARKING CERTAIN HOURS", OF CHAPTER 222, "VEHICLES AND TRAFFIC" OF THE CODE OF THE TOWNSHIP OF COLTS NECK, COUNTY OF MONMOUTH, AND STATE OF NEW JERSEY

WHEREAS, the power of the Township Committee to regulate streets is set forth in N.J.S.A. 40:67-1 et seq.; and

WHEREAS, the Township Committee believes a change is needed in the Township Code to include several additional streets in its schedule of streets on which parking is prohibited at certain hours of the day ("Schedule II"); and

WHEREAS, the Township Committee believes the streets in need of addition to Schedule II have experienced significant changes in volume of traffic

NOW THEREFORE BE IT ORDAINED, by the Council of Colts Neck Township, County of Monmouth, and State of New Jersey, as follows (additions to text indicated by <u>underline</u>; deletions to text indicated by strikeout):

§ 222-24 Schedule II: No Parking Certain Hours.

In accordance with the provisions of § 222-4, Unless stated otherwise, the provisions of § 222-4 shall apply to all streets named in this section. nNo person shall park a vehicle between the hours specified upon any of the following described streets or parts of streets:
