

**RESOLUTION 2023-179**

**AUTHORIZING ACCEPTANCE OF  
A PERFORMANCE SURETY GUARANTEE,  
A CASH PERFORMANCE GUARANTEE AND  
INSPECTION FEE FOR EXPRESS AUTO SPA  
BLOCK 48, LOT 6 – 297 ROUTE 34  
ZB1093**

WHEREAS, on June 28, 2023, Township Engineer, Glenn Gerken issued a memo addressed to the Zoning Board of Adjustment members recommending various conditions to include a performance guarantee and inspection fee for Express Auto Spa, Block 48, Lot 6; and

WHEREAS, Township Planner, Timothy Anfuso collected the performance surety bond from Atlantic Specialty Insurance Company, Bond# 800158375 in the amount of \$20,890, a cash performance guarantee by Check No. 1158 in the amount of \$2,321.00 and an inspection fee by Check No. 1158 in the amount of \$10,355.52 and issued a memo to the Municipal Clerk dated November 29, 2023 requesting a resolution of the Township Committee to accept the performance surety bond guarantee, cash performance guarantee and inspection fee.


