## AUTHORIZING ACCEPTANCE OF A PERFORMANCE GUARANTEE REDUCTION AND CASH GUARANTEE REDUCTION FOR KLING CLOVER HILL ROAD PRELIMINARY AND FINAL MAJOR SUBDIVISION BLOCK 7.02, LOTS 34.01 AND 34.12 PB740

WHEREAS, on October 21, 2021, the Township Committee adopted Resolution 2021-187 accepting the performance guarantee in the amount of \$952,948.80 and a cash guarantee in the amount of \$105,883.20; and

WHEREAS, on December 4, 2023, Township Engineer, Glenn Gerken issued a memo addressed to Tim Anfuso, Township Planner, recommending a reduction to the performance guarantee and cash guarantee; and

WHEREAS, Township Planner, Timothy Anfuso collected Bond Rider# CIC1911854 from Capitol Indemnity Corporation reducing the original bond to \$28,885.00. Mr. Anfuso issued a memo dated December 14, 2023 to the Municipal Clerk requesting a resolution of the Township Committee to accept the performance guarantee reduction from \$952,948.80 to \$285,885.00 and the cash performance guarantee reduction from \$105,883.20 to \$31,765.00.

- 2. Acceptance of a Cash Performance Guarantee reduction from \$105,883.20 to \$31,765.00.
