

RESOLUTION 2025-145

**RESOLUTION AUTHORIZING CHANGE ORDER NO. 1 TO THE CONTRACT
AWARDED TO FERNANDES CONSTRUCTION, INC. FOR THE FY 2024
MUNICIPAL AID PROGRAM – IMPROVEMENTS TO HEYERS MILL ROAD
FROM CONOVER ROAD TO HERITAGE LANE**

WHEREAS, by Resolution 2025-72, dated March 12, 2025, Colts Neck Township (“Township”) authorized the award of a contract for FY 2024 Municipal Aid Program – Improvement to Heyers Mill Road from Conover Road to Heritage Lane; and

WHEREAS, in accordance with New Jersey’s Local Public Contracts Law (N.J.S.A. 40A:11-1, et seq.), the Township solicited bids for the FY 2024 Municipal Aid Program – Improvement to Heyers Mill Road from Conover Road to Heritage Lane and publicly opened bids on March 4, 2025; and

WHEREAS, the contract was awarded per Resolution 2025-72 to Fernandes Construction, Inc. for a contract price of \$531,863.74; and

WHEREAS, proposed Change order No. 1 increases the total Contract price from \$531,683.74 to \$567,526.48, an increase of 6.71%, \$35,662.74.

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that it hereby authorizes Change Order No. 1 to include the following:

- Adding 650 linear ft. of curb/turf restoration at the municipal site (\$25,000.00)
- Adding additional mill/pavement south of Heritage Lane to repair transformer damage (\$4,000.00)
- Additional Police time (\$6,550.00)
- Additional restoration behind the curb as required by the grades

BE IT FURTHER RESOLVED, the Township Administrator, Mayor, and Township Clerk are hereby authorized and directed to execute any and all documents in connection with this change order; and

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the following:
