RESOLUTION INCREASING BID THRESHOLD AND QUOTATION THRESHOLD

WHEREAS, a contracting unit with a purchasing agent who possesses a qualified purchasing agent certificate pursuant to N.J.S.A. 40A:11-9 desiring to take advantage of the supplemental authority of N.J.S.A. 40A:11-3 and 40A:11-4.3 shall have its governing body pass a Resolution authorizing the amount of a higher bid threshold for the contracting unit, the amount of which shall not exceed the statutory maximum bid threshold; and

WHEREAS, John Antonides is a Qualified Purchasing Agent with Certification No.Q-0788 issued by the State of New Jersey Department of Community Affairs Division of Local Government Services; and

WHEREAS, pursuant to N.J.S.A. 40A:11-3 the State Treasurer has increased the bid threshold to \$53,000.00 for entities subject to the Local Public Contracts Law whose purchasing agents possess a Qualified Purchasing Agent ("QPA") certificate awarded by the Division of Local Government Services. In addition, the net quotation threshold established by the State Treasurer for local units with QPA's is \$7,950.00 (15% of the \$53,000.00 QPA bid threshold);

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of Colts Neck Township that John Antonides as Qualified Purchasing Agent for Colts Neck Township is hereby authorized to exercise the duties of a Qualified Purchasing Agent pursuant to N.J.S.A. 40A:11-2(30) with specific relevance to the authority, responsibility and accountability of the purchasing activity of Colts Neck Township; and

BE IT FURTHER RESOLVED that Colts Neck Township pursuant to **N.J.S.A.** 40A:11-3 hereby increases its bid threshold to \$53,000.00 and also increases its new quotation threshold to \$7,950.00 (15% of the \$53,000 QPA bid threshold); and

BE IT FURTHER RESOLVED that the Township hereby authorizes the Qualified Purchasing Agent to negotiate and award fair and open contracts and non-fair and open contracts or both below the bid threshold; and

BE IT FURTHER RESOLVED that the Township Clerk is hereby authorized and directed to forward a certified copy of this Resolution to the Director of the Division of Local Government Services.
