**RESOLUTION REQUESTING THE MONMOUTH COUNTY
BOARD OF COUNTY COMMISSIONERS FORMALLY NAME
AND DEDICATE THE COLTS NECK CIRCLE AS
THE LILLIAN G. BURRY MEMORIAL CIRCLE**

WHEREAS Lillian G. Burry served as the founding member and president of the Matawan League of Women Voters and the first woman elected to the Matawan Borough Council,

WHEREAS Lillian G. Burry served three terms on the Colts Neck Township Committee and three times as mayor and a champion of Historic and Open Space Preservation,

WHEREAS Lillian G. Burry was first elected to the Monmouth County Board of Chosen Freeholders in November 2005, reelected in 2008, 2011, 2014, 2017 and reelected to the Board of County Commissioners in 2020, serving as the liaison to the Board of Elections, Planning Board, Agricultural Board, and Consumer Affairs.

WHEREAS Lillian G. Burry was appointed to the Fort Monmouth Economic Revitalization Planning Authority serving as Vice Chair and to the Fort Monmouth Economic Revitalization Authority, where she chaired the Veterans Affairs Sub-Committee and served on the Real Estate Sub-Committee. She was appointed by the Commissioner of the Interior, to the Fort Hancock 21st Century Advisory Committee for the National Park Service,

WHEREAS Lillian G. Burry earned countless awards and recognition for more than fifty years of dedicated public service leaving an indelible mark of service and contribution to Monmouth County,


NOW, THEREFORE BE IT RESOLVED, I, Tara Torchia Buss, Mayor of Colts Neck Township, together with the entire Township Committee formally request the Monmouth County Board of Commissioners formally name and dedicate the county traffic circle as The Lillian G. Burry Memorial Circle.

BE IT FURTHER RESOLVED, that the Township Committee of Colts Neck Township requests all municipalities in Monmouth County to adopt a resolution requesting the same.
