WHEREAS, Piazza & Associates, Inc. is an experienced firm that provides such affordable housing services and has presented a proposal for same; and

WHEREAS, it is in the best interest of the Township to enter into an agreement with Piazza & Associates, Inc. to provide support services in connection with its affordable housing administration.
