**APPROVING A SHARED SERVICES AGREEMENT BETWEEN
COLTS NECK TOWNSHIP AND THE
COUNTY OF MONMOUTH THROUGH THE
MONMOUTH COUNTY SHERIFF'S OFFICE, COMMUNICATIONS DIVISION
FOR PARTICIPATION IN THE PUBLIC SAFETY ANSWERING POINT (PSAP)
AND PUBLIC SAFETY DISPATCH POINT (PSDP) DISPATCH SERVICES
(2026-2030)**

WHEREAS, Colts Neck Township entered into a Shared Service Agreement for participation in the Public Safety Answering Point (PSAP) and Public Safety Dispatch Point (PSDP) programs for emergency dispatch services with the Monmouth County Sheriff's Office, Communications Division; and

WHEREAS, under the terms of said Agreement, the Communications Division will serve as the Public Safety Answering Point (PSAP) and Public Safety Dispatch Point (PSDP) for Colts Neck Township, and

WHEREAS, by way of Resolution 2023-49 Colts Neck Township authorized an agreement to continue Emergency Dispatch Services with the Monmouth County Sheriff's Office from January 1, 2023 through December 31, 2025; and

WHEREAS, the Township received a letter and new agreement from Monmouth County Commissioner, Thomas A. Arnone dated June 12, 2026, to continue participation in the PSAP and PSDP programs for dispatch services for a five-year period commencing January 1, 2026 through December 31, 2030; and

WHEREAS, for dispatch services as outlined in the agreement attached hereto, the Township will pay Monmouth County an annual fee of \$116,913.00 for 2026 with an increase of 2% in 2027, 2028, 2029 and 2030; and

NOW THEREFORE BE IT RESOLVED, by the Township Committee of Colts Neck Township that it hereby authorizes the Mayor and Municipal Clerk to execute a shared services agreement between Colts Neck Township and the County of Monmouth and the Monmouth County Sheriff's Office for Monmouth County, under the auspices of the Monmouth County Sheriff's Office, Communications Division, to serve as the Public Safety Answering Point (PSAP) and Public Safety Dispatch Point (PSPD) pursuant to the agreement attached hereto.

BE IT FURTHER RESOLVED AND CERTIFIED by John Antonides, Chief Financial Officer, that funds for this purpose are provided through the Budget Account #06-01—044-581.
