

# VILLAGE OF CORWIN

RESOLUTION 02-2026

APRIL 13, 2026

**A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND CLERK-TREASURER FOR THE VILLAGE OF CORWIN, WARREN COUNTY, OHIO TO ENTER INTO A CONTRACT WITH JONES LAKE MANAGEMENT FOR THE SPRAYING OF CATTAILS AND VEGETATION IN ALL WATERWAYS WITHIN FURNAS FORGE AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Ohio Revised Code 731.47 entrusts the legislative authority with the responsibility of managing and overseeing the finances and assets of the Village unless specified otherwise;

**WHEREAS**, under the provisions of Ohio Revised Code, the Village of Corwin has the power to enter into contracts and allocate financial resources to care and maintain its easements and waterways that were previously cleaned out within Furnas Forge. The Village shall enter into a contract with Jones Lake Management to spray aquatic approved herbicides and surfactants necessary to control cattails and vegetation in those waterways on a monthly basis April through October, with no effect on aquatic life, in the best interest of the Village of Corwin's residents, enterprises and visitors;

**WHEREAS**, there is a need to expedite this treatment for uninterrupted services, thereby safeguarding the public peace, well-being and safety of the Village.

**SO NOW THEREFORE, BE IT RESOLVED** by the Village of Corwin Ohio, Village Council, at least two-thirds of members thereto concurring:

**Section 1:** The Village of Corwin Mayor and Clerk-Treasurer are hereby authorized to enter into a contract with Jones Lake Management in the amount of \$1,400 as described in the attached contract Exhibit "A" and incorporated herein.

**Section 2:** This Resolution is hereby declared to be an emergency in accordance with Ohio Revised Code 731.30 for the immediate preservation of the public peace, health, safety and general welfare, this Resolution shall be in full force and effective immediately upon passage.

**Section 3:** It is found and determined that all formal actions of the Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of the Council of the Village of Corwin in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
