Identity Theft	2019-12-05	Victim called to report fraudulent activity on his debit card, unlawful use of his Social Security Card and Driver's License. The suspect used the victims Driver's License, with a fake picture to purchase a vehicle in Florida. The suspect also opened an Insurance Policy through Progressive Insurance to insure the fraudulent purchase of the vehicle. There has been no monetary loss at this time. RP advised he has a credit monitoring service and they are watching his finances and social security number.
Traffic Stop - Citation	2019-12-12	Officer running stationary radar stopped a vehicle for speed, upon approaching the vehicle the officer could smell marijuana coming from the vehicle. Officer searched the vehicle and found what later tested to be 3 grams of marijuana and paraphernalia. Driver was cited for small amount in a motor vehicle, possession of paraphernalia, and no current proof of insurance with verbal warnings for speeding and No DL in possession.
Traffic Stop - 2nd Degree DWI - Arrest	2019-12-13	Officer stopped a vehicle for equipment violations and the driver showed signs of alcohol impairment. Further investigation led to a DWI arrest of Annika Nikole Leiknes, age 26 of St. Paul. The driver agreed to a breath test with a reported value of .19 AC. The driver was booked at the Hennepin County Jail for 2nd Degree DWI and Careless Driving.
Traffic Stop - Citation	2019-12-19	Stopped for driving without tail lights. Found to be violating curfew and driving with no MNDL. Cited accordingly.
Traffic Stop - 3rd Degree DWI - Arrest	2019-12-20	Officer stopped a vehicle for speeding and multiple moving violations. The driver, 36 year old Viengnakone Praviseth, of Minneapolis, exhibited clues of impairment and refused roadside tests. The driver later agreed to take a breath test which resulted in a reported value of .11 BAC. The driver had one prior DWI conviction making this a 3rd Degree DWI. The driver was ultimately booked into Hennepin County Jail.
Property Damage	2019-12-23	RP and driver came to PD lobby to report driver hit a bank of mailboxes and did not stop. RP located driver down the road and brought him to PD to report damage.
