Illegal Dumping - Verbal Warning	2021-01-07	Officer observed a Deephaven resident drive up to the Carson's Bay dumpster and dump household items into it. Officer verbally warned the individual.
Traffic Stop - Citation	2021-01-09	Verbal Warning for Speed. Cited for Curfew. Father was contacted and advised.
1st Degree Burglary	2021-01-14	Officer responded to a burglary of a residence where unknown suspect(s) entered an occupied dwelling and took two laptops, a phone, and a wallet. Officer gathered information and Hennepin County Crime Lab was started to process the scene. Investigation continues
Vehicle Theft/Recovered	2021-01-14	Resident reported that their 2014 Honda Accord was stolen from the driveway. Three cars were parked in the driveway, all unlocked. The suspect located keys to the Honda in another vehicle and took the Honda. The vehicle was recovered in Minneapolis. The vehicle was towed to DPD and processed by HC Crime Lab. Vehicle was released to owner. Investigation continues
1st Degree Burglary / Vehicle Theft	2021-01-14	Officer responded to a burglary of a residence where the unknown suspect entered an occupied dwelling and took a wallet, and stole a vehicle from the driveway. Officer gathered information and Hennepin County Crime Lab was started to process the scene. Investigation continues
Traffic Stop - 2nd Degree DWI Arrest	2021-01-19	Officer was on routine patrol when Officer observed a silver Audi sedan make several moving violations. Officer initiated a traffic stop on the vehicle. Officer observed the driver to be under the influence of alcohol. Officer had the driver step out to perform standard field sobriety tests in which the driver failed. Driver provided a PBT of 0.094. Driver was arrested for DWI. Due to prior DWI's this caused the arrest to be a 2nd Degree DWI and the driver's vehicle was forfeited. Lora Danielle Hosek, 52 of Minneapolis agreed to take a breath test and provided a BAC of 0.12. Driver was transported to jail without incident.
