Tamper with Vehicle	2019-01-02	Officer was dispatched to an attempted theft from motor vehicle that had just occurred. Officer searched area and did not find suspect vehicle. Nothing was taken from vehicle.
Theft From Vehicle	2019-01-05	RP came out this morning to find his vehicle ransacked and a handful of change missing.
Traffic Stop - Narcotics - Citation	2019-01-05	Officer stopped a vehicle for a moving violation. Driver was cited for Possession of small amount Marijuana in a vehicle, Expired license and Possession of Drug Paraphernalia.
Identity Theft/Mail Theft	2019-01-08	A resident called to report possible mail theft and fraudulent mail forward as well as a credit card was fraudulently opened in his name.
Theft From Auto / Recovered	2019-01-10	RP called to report a gym bag and backpack were taken from his vehicle last night. Officer gathered the information and gave the RP this case number and advised to make sure his vehicles were locked.
Theft Report	2019-01-11	RP called to report a package from Mediacom was taken from his front porch. Officer called the RP and gathered the information, gave the party this case number, and advised him to check his mail deliveries everyday.
2 <sup>nd</sup> Degree DWI	2019-01-16	Officers dispatched to one who appeared to be intoxicated trying to pick up his child from school. Officer made contact with the driver who started the vehicle to roll down the window. Officer noticed a moderate odor of a consumed alcoholic beverage and asked the subject to perform field sobriety tests. Driver failed FST's and provided a PBT sample of .251. <b>Peter Sean Dunlavy, 51 of Chanhassen</b> was arrested and provided a .30 BAC breath sample. Dunlavy and was booked into Hennepin County Jail.
3 <sup>rd</sup> degree DWI	2019-01-19	Officer was called to a vehicle leaving the scene of a minor property damage crash. Officer stopped the vehicle and confirmed that the driver had been speeding and ran into the utility pole. The driver was unable to satisfactorily complete the field sobriety exercises and was placed under arrest. <b>Melissa Cates Robillard, 54 of Deephaven</b> , was arrested and submitted a breath test of .19 ac. The driver was transported to Hennepin County Jail for 3rd degree DWI.
