INCIDENT	DATE REPORTED	INCIDENT DETAILS:
Mail Theft	2019-07-02	A resident called to report past action mail theft, after discovering an insurance check that was sent to him was cashed by an unknown person.
Traffic Stop - Citation - Small Amount of MJ - Minor Tobacco	2019-07-02	Officer conducted a traffic stop for an equipment violation that resulted in two citations for small amount of marijuana and one citation for underage possession of tobacco.
Theft from Auto	2019-07-03	Officer received a phone call for a theft from auto that occurred at Deephaven Main Beach. The reporting party stated that he left his car unlocked at the beach and his Wilson tennis racket was taken out of his truck. The reporting party just wanted the police department to be aware of the incident.
Traffic Stop - Citation	2019-07-04	Officer stopped vehicle for possible curfew violations and in the park after hours. Further investigation and a search of the vehicle yielded a small amount of marijuana.
Underage Consumption- Flee on Foot	2019-07-07	Officer observed a group of young adults at the Deephaven Beach. The group fled the officer on foot when Officer approached. One male was detained and cited for underage consumption of alcohol.
5th Degree Assault - Mental Health Hold	2019-07-07	Officer was dispatched to an assault. Officer arrived and rendered aid to the victim until paramedics were on scene. The suspect and victim were transported to HCMC. Suspect was charged via Formal Complaint for Assault.
Traffic Stop - Citation	2019-07-07	Driver was stopped for displaying expired registration and after investigation cited for possession of drug paraphernalia.
Damage to Property	2019-07-11	Officer dispatched to a row of mailboxes that had been damaged. Officer arrived and documented the damage, and spoke with the RP. He said his wife heard a "thud" outside around 2300 hours. When she left this morning around 0720 hours she noticed the damage. RP was advised of this case number and to contact his neighbors on how to replace the stand.
Theft From Vehicle	2019-07-11	RP called to report his laptop was taken three months ago from a friend's car. He did not know which city it was taken from. RP said he has been trying to locate it via "Find my Phone app". Officer gathered the information, and gave the RP this case number.
Traffic Stop -	2019-07-11	Officer conducted a traffic stop for an equipment

Citation		violation. Officer approached the vehicle and smelled an odor of marijuana emanating from the vehicle. Officer located 1 gram of marijuana and drug paraphernalia in the vehicle. The driver was given a verbal warning and the juvenile in possession of the marijuana and paraphernalia was cited.
