INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Runaway - Returned	2022-07-02	Officer was dispatched near the listed residence, for a 12-year-old who rode away from his parents on a bike ride after a verbal altercation. Officers searched the area for hours looking for the juvenile with no success. The juvenile eventually returned home safely.
Property Damage	2022-07-09	A resident called to report damage to a mailbox that occurred over night, they advised the security cameras didn't pick up a suspect. The resident believes the neighbor is the suspect as they've had an ongoing feud and got into an argument yesterday about the dog chasing after him. The homeowner reported the value at \$150.
Burglary - Arrest	2022-07-09	A resident called to report someone was in their second home which is under construction, the person met them at the door and told the homeowner they weren't the owner of the property and to leave. An officer later made contact with the subject at the front door who said she was cleaning; the officer arrested the party at the door and with the assistance of South Lake Minnetonka Police the home was searched and found clear. One adult female from California was booked into the Hennepin County ADC for burglary.
4th Degree DWI- Formal Complaint	2022-07-09	Vehicle stopped for a headlight out. Driver pulled into the Holiday Station lot and stopped before I activated my lights. While speaking to the driver, I detected an odor of consumed alcoholic beverage on her breath. She was asked to perform FST's and failed. Michell Anne Lindstrom, 39 of Minnetonka was arrested. Subject submitted to breath test, with a result of .15ac. Subject was transported home by the CSO.
Damage to Property	2022-07-22	RP called the PD to report her mailboxes were knocked over during the night. Officer arrived spoke with the RP and advised her to go ahead and repair them. But advise the PD of the final cost.
