Identity Theft	2019-03-07	RP wanted to report an identity theft case but was currently in Singapore. Officer attempted to contact the RP but the

		numbers given by dispatch were not in service.
DWI/ 5th Degree Possession - Arrest	2019-03-13	While on routine patrol Officer noticed a vehicle off road in a snow bank at Maplewood Road and Maple Ridge Road in Woodland. Officers observed that the driver was impaired. Officers conducted Field Sobriety Tests on Julie Sarah Mearthy, 28 of Minneapolis and placed the driver under arrest for DWI. The driver tested a .19 ac and was transported to Hennepin County Jail for Third Degree DWI, and 5th Degree Possession of a Controlled Substance.
Fraud	2019-03-14	Officer took a report of losses incurred due to a scam involving the reporting party's computer.
3rd Degree DWI- Arrest	2019-03-16	Officer was dispatched to a vehicle in a ditch at Park Avenue and Deephaven Avenue. Officer investigated and learned the driver was under the influence of alcohol. The driver, Shawnee Marie Farrell, 33 of Excelsior submitted to a breath test with a result of .16 ac. Farrell was transported to Hennepin County Jail and charged with 3rd Degree DWI.
FTC Fraud	2019-03-18	A resident called to report credit card fraud on his account.
Traffic Stop - Citation	2019-03-20	Citation - underage possession of tobacco
Traffic Stop - Warrant Arrest - Citation	2019-03-24	Officer conducted a traffic stop for an equipment violation, driver was arrested on multiple warrants and passenger cited for small amount of Marijuana.
Fraud	2019-03-25	A resident reported fraudulent charges on his credit card, unknown how the charges occurred as the resident had possession of the card. Resident is working with the bank to report the charges as fraudulent and needed a police report number.
