INCIDENT	INCIDENT DATE	INCIDENT DETAILS:
Credit Card Fraud	2023-02-01	A resident called to report that their credit card was compromised and two transactions were attempted for online orders with a delivery address in Roseville, one transaction went through but was canceled with no loss at this time.
DWI - Arrest	2023-02-06	Driver stopped on Minnetonka Bl. and Northome Bl. for driving too fast for conditions. The driver, Taylor James Ferris, 24 of Minnetonka was arrested for 3rd degree DWI. Driver submitted a breath test with a result of .17ac. The subject was brought to Hennepin County jail.
PD Accident- Possession of Marijuana in MV	2023-02-14	An officer was dispatched to a PD crash at Highway 7 and Vine Hill Road. Officer arrived and gathered information. Excelsior Fire assisted with traffic control and cleaning debris. One driver was cited with possession of marijuana in a motor vehicle. Both vehicles were towed to Williams Towing for severe disabling damage.
Vehicle Tampering	2023-02-14	An officer received a phone call that a resident's vehicle had been gone through sometime in the last 2 days. The resident said her glovebox and center console had been left open and her items were scattered in the vehicle. The RP said nothing appeared to be missing or damaged but wanted law enforcement to be aware.
Theft	2023-02-25	Resident had prescription Vicodin stolen from her apartment while she was admitted in the hospital.
Traffic Stop - Verbal Warning	2023-02-26	An officer conducted a traffic Stop on a vehicle for speed, the driver was warned for speed and curfew and the passenger was warned for curfew. A parent was contacted and confirmed the juveniles were returning from the movie theater.
