INCIDENT	INCIDENT DATE	INCIDENT DETAILS
3rd Degree DWI- Open Bottle - Arrest	2023-03-04	Officer stopped a driver and found the driver was impaired by alcohol. Driver failed FST's and was arrested. <b>Sharon Marie Burt, 60 of Excelsior</b> was taken to the PD for a breath test. suspect blew a .26 ac. She was booked into to Hennepin County jail. She was charged with 3rd degree DWI and Open Bottle.
Traffic Stop - Narcotics	2023-03-09	Officer was on stationary patrol and observed a tail light out on a vehicle. Officer conducted a traffic stop on the vehicle and contacted the juvenile driver. Officer observed a marijuana smoking device in the vehicle. Officer then searched the vehicle and located marijuana, along with more marijuana smoking devices. Driver was released to his father. Formal Complaint charges are pending with the County Attorney.
Credit Card Fraud	2023-03-16	A resident called to report a Best Buy credit card had been opened in their name with fraudulent charges made at the Eagan store. Under Investigation
Traffic Stop - Warrant Arrest	2023-03-16	Officer stopped a vehicle after running the license plate and seeing an active warrant. The driver was arrested for a Scott County warrant. The officer met up with a Scott County Deputy to turn the arrested over.
1 <sup>ST</sup> Degree DWI Arrest	2023-03-19	Officer stopped a driver for speeding on Breezy Point Rd. The driver, a 40-year-old man from Minneapolis, was found to be impaired and failed FST's and DRE evaluation. A warrant was obtained for Blood. The subject was arrested and transported to Hennepin County Jail on 1st degree DWI charges. Waiting for Toxicology results.
Phone Scam	2023-03-24	A resident called the police department to report they had fallen victim to a phone scam. Spanish speaking callers called her and said they had her daughter, panicked the resident sent two Money Gram transactions to Mexico for a total of \$2,000. The resident was working with the bank to reverse the transactions.
Damage to Property	2023-03-26	Officer received a complaint about damage to the Thorpe Park warming house restroom. The officer arrived and found the inside of the bathroom had been covered in toilet paper

		and paper towels. The officer also found the paper towel dispenser had been pried open and damaged. Cost to replace dispenser is \$600 dollars.
Fraud Report	2023-03-28	An officer took a lobby walk-in report of fraud. The victim purchased \$500 worth of iTunes gift cards for someone he thought was his boss. Under Investigation.
Traffic Stop - Citation - Warrant Arrest	2023-03-28	Officer stopped a vehicle for coming to a stop in the traffic lane then driving onto the sidewalk. The Officer smelled the odor of marijuana in the vehicle and the driver admitted to having several marijuana cigarette ends in the center console. The passenger of the vehicle was found to have a felony body only warrant and a methamphetamine pipe. The driver was issued a citation and the passenger was arrested and taken to Hennepin County Jail.
