Burglary	2025-05-01	Officer received a phone call in regards to a possible past action burglary. RP believes it occurred in the past 3 weeks, while out of town. RP is in the process of making a list for his missing items. Investigation active at this time.
Suspicious Activity -Alcohol/ Drug Citation	2025-05-05	Officer located an occupied vehicle at Main Beach. Officer spoke to the individuals and smelled burnt marijuana. The Officer saw a container of "RAW Wrapping" papers in the center console and asked the driver how much marijuana was in the vehicle. The driver admitted to only having one "joint" in the car. The vehicle was searched and the Officer found a small bag of marijuana and a marijuana grinder. The driver also admitted to having two bottles of Fireball Whisky in the passenger door. I issued the driver a citation for the under 21 possession of alcohol and possession of marijuana.
Assault-Disorderly Conduct	2025-05-07	Officer called to the Deephaven Elementary School for a report of two females fighting. RP stated that the individuals had left the scene prior to law enforcement arrival. Office obtained video from the school and interviewed both parties. One subject was charged via Formal Complaint, for Assault and Disorderly Conduct.
AOA - DWI - Arrest	2025-05-14	Officer located two males sleeping in a vehicle stopped at a stop light. The officer watched the vehicle go through one light cycle before driving past the vehicle to turn around and get behind it. The officer approached with a Wayzata PD Officer and found two males sleeping. The vehicle was in drive and was running. The officer turned off the vehicle and woke the male driver. The driver smelled of alcohol and exited the vehicle to preform SFSTs. The male was arrested and found to have a BAC of 0.16.
Traffic Stop- False Info- Warrants- Arrest- Stolen Vehicle	2025-05-21	Officer saw a vehicle traveling down the trail near the Police Department. The driver of the vehicle got off the trail and ran a stop sign. Officer stopped the vehicle and found out the driver had Warrants form out of County. The driver had recently stolen the vehicle from Minneapolis at 2239 hours. Driver was brought to jail for

		his warrants and will be charged with Vehicle Theft and Possession of Stolen Property.
