Issuance of Permit. The Town shall issue the permit upon satisfactory compliance by the applicant with all provisions of Dekorra Ordinance 6.08. The Town Board shall investigate whether to issue any fireworks permit and, if satisfied, the Town Board Chairperson shall execute all fireworks permits. Prior to issuance of the fireworks permit, the applicant shall furnish the Town with a certificate of insurance showing public liability insurance for the proposed location of selling or using/displaying fireworks as follows: (1) For selling fireworks: insurance in an amount of not less than \$1,000,000 per person, \$3,000,000 aggregate and \$500,000 in property damage. (2) For using/displaying fireworks: insurance in an amount of not less than \$1,000,000 per person/aggregate and \$500,000 in property damage. If the license is denied at the Town Board Meeting, the Clerk shall provide the applicant a letter with reasons for denial of their permit. Any applicant denied a permit may appeal the decision and request a hearing before the Town Board by writing a letter to the Town Clerk within 14 days of receipt of the denial letter. The letter should state in detail the grounds for reversal of the denial and shall be signed by the applicant. The Town Clerk shall set a date and time to meet with Town Board. I acknowledge that the information provided in this application is true and correct to the best of my knowledge and belief. I certify I am familiar with the laws, ordinances and regulations pertaining to the sale of fireworks and I agree to obey all provisions of the law. I understand that falsification of this application will result in automatic denial.
