A Permit is required to bring dogs to the Town of Dekorra dog exercise area. Dogs must be licensed by the municipality in which they reside in order to obtain a dog park permit. Dog park permits shall be displayed on the dashboard or other conspicuous location of the vehicle that transported the dog to the exercise area or on your person if you walked your dog to the park. Fees established by the Town of Dekorra help cover the costs of maintaining the park. Applicant agrees to abide with all Dekorra rules for use of the park. All dogs must be vaccinated against rabies.
