 - c) residence of applicant
- 4) Certificate indicating applicant has been fingerprinted
- 5) Provide two (2) photographs, not more than one year old, of passport size, which must be exhibited.

CHAPTER IV
GENERAL LICENSING

4-1 SOLICITORS, PEDDLERS AND JUNK DEALERS.

4-1.1 Definitions.

a. "Solicitor" shall mean any person (1) selling goods by sample or taking-orders for future delivery-with or-without accepting an advance of payment for the goods; or (2) requesting charitable contributions either by oral request or by the delivery of printed material; or (3) offering personal services, by the solicitor or any other third party, for compensation, either direct or indirect.

b. "Peddler" shall mean any person who goes from place to place to traveling on the streets from house to house and carries with him goods, wares, or merchandise of any description for the purpose of selling and delivering them to purchasers.

c. "Junk dealers" shall mean any person who goes from place to place by traveling on the streets from house to house purchasing old papers, rags, metals, or any other type of junk material.

4-1.2 License Required.

No person, firm, partnership, association or corporation shall engage in the usual activities of a solicitor, peddler or junk dealer, without first having obtained a license to engage in such activity from the borough clerk.

4-1.3 Application, Fingerprint, Photograph.

All applications for licenses shall be in writing on forms furnished by the Borough of Englewood Cliffs, signed by the applicant or the agent of the applicant and presented to the borough clerk. The said application shall state the name of the applicant, the correct name under which the business is being operated, the residence of the applicant, and such other pertinent information as may be considered necessary to properly consider the application. No application shall be granted unless the applicant shall provide the borough clerk with a certificate indicating that he has been fingerprinted by the chief or other proper police officer of the Borough of Englewood Cliffs. The applicant shall also provide a recent photograph, not more than one year old, of passport size, which may be exhibited upon request during the pursuit of his business.

4-1.4 Expiration of License.

All licenses issued pursuant to this section shall expire on May 31 of each year.

4-1.5 Fees.

Fees for licenses issued pursuant to this chapter shall be as follows: five (\$5.00) dollars per day; twenty-five (\$25.00) dollars per month; one hundred (\$100.00) dollars per six months; or two hundred (\$200.00) dollars per year; or a proportional amount for the fractional part thereof.

4-1.6 Violations.

Any person convicted of violating any of the provisions of this section shall pay a fine not exceeding two hundred (\$200.00) dollars for each offense or shall be imprisoned for a term not exceeding 90 days, or both.

4-1.7 Revocation of License.

All licenses issued hereunder may be revoked at any time by the issuing authority for failure or refusal on the part of the licensee to comply with the terms, conditions and provisions of this section. Said license, when issued, shall be displayed by the licensee on request at all times when actually engaged in canvassing, soliciting, distributing, or calling from house to house within the borough limits of the Borough of Englewood Cliffs.

4-1.8 Canvassing. Hours Permitted.

Licensees shall have the right to canvass within the Borough of Englewood Cliffs only on weekdays and Saturdays during the hours from 10:00 a.m. to 4:00 p.m. and shall conduct themselves in a lawful manner at all times.

ORDINANCE NO. 22-06

ORDINANCE AMENDING SECTION 4-1 TITLED "SOLICITORS, PEDDLERS AND JUNK DEALERS"

WHEREAS, the Borough of Englewood Cliffs maintains Ordinance § 4-1, titled "Solicitors, Peddlers and Junk Dealers"; and

WHEREAS, Section 4-1.4 sets forth an application, fingerprinting, and photographing process; and

WHEREAS, the Borough Council seeks to amend the Ordinance to reflect current practices.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Englewood Cliffs, County of Bergen, State of New Jersey, as follows:

SECTION 1. Ordinance § 4-1 is hereby amended as follows:

4-1 SOLICITORS, PEDDLERS AND JUNK DEALERS

4-1.1 to 1.2 [NO CHANGES]

4-1.3 .Application, Fingerprint, Photograph.

All applications for licenses shall be in writing on forms furnished by the Borough of Englewood Cliffs, signed by the applicant or the agent of the applicant and presented to the borough clerk. The said application shall state the name of the applicant, the correct name under which the business is being operated, the residence of the applicant, and such other pertinent information as may be considered necessary to properly consider the application. No application shall be granted unless the applicant shall provide the borough clerk with a certificate indicating that he has been fingerprinted by the chief or other proper police officer of the Borough of Englewood Cliffs, or in the alternative, a vendor to be designated by the Borough of Englewood Cliffs to perform such fingerprinting. The applicant shall also provide a recent photograph, not more than one year old, of passport size, which may be exhibited upon request during the pursuit of his business.

4-1.4 to 1.8 [NO CHANGES]

SECTION 2. All Ordinances or parts of ordinances of the Borough of Englewood Cliffs which are inconsistent with the provisions of the Ordinance are hereby repealed to the extent of any such inconsistencies only.

SECTION 3. If any section, subsection, sentence, clause or phase of this Ordinance is, for any reason, held to be unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect any and/or all of the remaining provisions of this Ordinance.

BE IT FURTHER ORDAINED as follows:

a. Within five (5) days (Sundays excepted) of adoption on second reading, this Ordinance shall be presented to the Mayor for his signature by the Acting Borough Administrator;

b. Within ten (10) days (Sundays excepted) of receipt of this Ordinance, the Mayor shall either approve this Ordinance by affixing his signature hereto or shall return it, unsigned, together with a written statement of his veto and objections to the Ordinance as a whole or any parts thereof;

c. The return of the Ordinance and written objections shall be made by the Mayor and given to the Acting Borough Administrator, who shall forthwith provide same the Borough Council;

d. This Ordinance shall not take effect without the Mayor's approval, unless the Mayor fails to return the Ordinance to the Borough Council as set forth above, or unless, following the return of the Ordinance with the Mayor's veto and objections, the Borough Council shall, by a vote of two-thirds of the members of the Borough Council, resolve to override the Mayor's veto.

e. In the absence of a Mayoral veto or an override of the Mayoral veto, the Ordinance shall take effect pursuant to the above and after publication.
