ARTICLE I. DEFINITIONS

- A. Authorized Adult: means a minor's parent, guardian, or any person 21 years or older authorized by a minor's parent, guardian, or other legal representative to accompany said minor on public property after curfew.
- B. City Facilities: include City Parks and the splash pads.
- C. City Parks: include the North Park, the Wildlife Park, the Blue Star Park, and amphitheaters or pavilions at the North Park, the Wildlife Park, and the City Building.
- D. Local Residents: means individuals living within Fillmore City limits.

ARTICLE II. GENERAL POLICY

A. MAINTENANCE

The Mayor, with the advice and consent of the City Council, shall appoint maintenance personnel.

B. USE

- (1) General use: All users are required to leave the City Facilities clean and free of trash and litter.
- (2) Renting City Facilities:
 - a. If available and if scheduled in advance with the Fillmore City Office, certain City Facilities may be rented for public or private activities and events. A City Facility will not be officially booked until the Rental Agreement is signed, and a fee received pursuant to II.B.3., "Fees."
 - b. City Facilities are generally available to rent at any time those Facilities are open to use. North Park in its entirety may not be reserved; however, amphitheaters, pavilions, and the splash pad at

- the North Park (lower section) may be rented. Reservations for any and all facilities in the upper section of the North Park are not available.
- c. Fillmore City reserves the right to open for public use or close City Facilities at certain times or on certain days. Length of rentals may be capped, at the time of signing the Rental Agreement, based on public and private demand, fairness to the public, and availability.

(3) FEES

- a. Light use: In order to cover the costs of service and maintenance, users will be charged fees for the use of the amphitheater lights, pavilion lights, and field lights, according to the Fillmore City Fee & Rate Schedule.
- b. Rentals: No park rental fee shall be charged to Fillmore City residents for use of City Facilities. Non-residents will be charged a daily park rental fee according to the Fillmore City Fee & Rate Schedule.

ARTICLE III. PROHIBITED ACTIVITIES

PROHIBITED ACTIVITIES IN OR ON CITY FACILITIES SHALL INCLUDE, BUT NOT BE LIMITED TO:

- 1) Defacing, displacing, or vandalizing any public structures, equipment, or property.
- 2) Excavating, digging, planting, or removing any landscaping, including soil, rock, sand, stone, tree, shrub, or plant.
- 3) Constructing or erecting any building or structure, whether permanent or temporary, or running any service utility across such land except with special permission from the City Council.
- 4) Climbing, walking, standing, or sitting upon any monument, vase, planter, fountain, railing, fence, or any other property not designated for such purpose.
- 5) Polluting any fountain, stream, or body of water in or adjacent to City Facilities.
- 6) Leaving rubbish, refuse, litter, of any kind, on the grounds.
- 7) Causing or permitting any animal to run loose at City Parks.
- 8) Hunting, molesting, or harming any wildlife.
- 9) Camping, setting up any tent, or parking any motor home or camp trailer for overnight use in or on any part of the City Facilities, including the parking lots.
- 10) Driving or parking a vehicle on any area except the paved roads or parking areas.
- 11) Using any weapons, including rifles, shotguns, air guns, spring guns, slingshots, bows, knives, etc.
- 12) Possessing or using fireworks.
- 13) Advertising of any kind.

- 14) Selling any merchandise, articles, or services, by individuals or entities unless sold as part of a public celebration or hired to provide services by a private party that is holding an event in the park. When this is the case, the private vendor must obtain written consent from the city on a case-by-case basis. Non-profit organizations may conduct fund raising activities with prior permission from the city.
- 15) Possessing or consuming any alcoholic beverages, tobacco products, or controlled substances.

ARTICLE IV. CELEBRATIONS

- A. Celebrations and private parties held in City Facilities shall be scheduled in advance with the Fillmore City Office and shall not include any of the prohibited activities except those specifically allowed in Article III of this policy.
- B. City Facilities are to be left clean and litter free following any public celebration or private use.
- C. Except as otherwise allowed by law, dogs are not allowed in any park at which a city celebration is taking place.

ARTICLE V. CLOSURE

City Facilities and the grounds of the Fillmore City Office shall be closed at the below listed times to juveniles (under the age of 18) pedestrian traffic (walk-through traffic) unless accompanied by an authorized adult: (revised 11/05/02, Ordinance 02-13)

Exceptions to this curfew may be granted on a case-by-case basis by the Fillmore City Council for special events.

The splash pads shall generally be available for use at the below listed times:

ARTICLE VI. PENALTY

Individuals who violate this policy may be banned from City Facilities. (revised 03/18/03; Ordinance 03-02)

ARTICLE VII. SPLASH PADS

A. GENERAL RULES

- 1) The splash pads are not supervised by a lifeguard. Supervision is required for children under 10 years of age by a responsible adult.
- 2) Appropriate swimwear must be worn. If a child is not toilet trained, a swim diaper is required.
- 3) In addition to the prohibitions under Article 3, the following apply to city splash pads:
 - a. Changing diapers is prohibited on splash pad premises.
 - b. Animals are prohibited on splash pad premises.
